The panel will select 12 photos for submission to HMDT from all eligible entries received by the Competition Closing Date for a chance to be chosen by HMDT as one of the 6 who will appear in the Exhibition.

The 12 entries to be submitted by TSA to HMDT will be determined in accordance with judging criteria to be produced by HMDT and published on the Scout website when known. The 12 entrants whose photos are selected for submission to HMDT will be notified, and where possible entrants who have not been successful will also be notified, using the email address provided on the entry.

Entrants shall be responsible for ensuring that the contact details they provide are up to date and accurate.

If any of the 12 selected entrants cannot be contacted by TSA, or no longer wish their entry to be submitted to HMDT, TSA reserves the right to select a substitute.

The TSA panel's decision is final, and The Scout Association will not enter into any correspondence regarding the same.

TSA cannot be responsibility for any entries lost, damaged or delayed whether due to transmission errors, website malfunction, computer error or otherwise.
